Reimbursements are conducted in accordance with the provisions of Article 19 of Act No. 129/1997 on the Mandatory Guarantee of Pension Rights and the Operations of Pension Funds.

Only those persons from abroad who are not citizens of EEA countries or USA* are entitled to a reimbursement of their pension fund contributions. The following countries are EEA members:

The EFTA countries: Iceland, Liechtenstein and Norway.

The EU countries: Britain, France, Germany, Sweden, Finland, Spain, Portugal, Italy, Denmark, Holland, Belgium, Luxembourg, Greece, Ireland, Austria, Estonia, Latvia, Lithuania, Poland, the Czech Republic, Slovakia, Hungary, Slovenia, Croatia, Malta, Cyprus, Bulgaria and Romania.

The reimbursement amounts to the entitlements fund less the cost of administrative expenses. The administrative fee is currently 20%, to the maximum amount of ISK 20,000, however, and withholding tax is paid on the amount in question.
